


The main topics of the Program include the following:

- **PERSONALIZED HEALTH CARE AND PUBLIC HEALTH IN THE DIGITAL ERA** (application of large data sets for prevention, screening and personalized therapeutic protocols, role of AI in health surveillance)
- **ETHICAL AND LEGAL CHALLENGES OF AI IN HEALTHCARE MANAGEMENT**

## School Organization




